

Home Care Pricing Schedule 2021/22

Resthaven delivers a flexible range of services in partnership with you to support your independence and preferred lifestyle, consistent with our values: Trust, Dignity, Choice.

Resthaven's service delivery model uses Resthaven employed staff (checked, trained and supervised), unless you prefer services subcontracted through another provider.

Travel

Travel with you for excursions/appointments/

shopping within a scheduled visit will be charged at a per kilometre (km) basis.

Where staff travel more than 5km to provide services to you, there is an additional travel package charge.

Standard Hours

Resthaven's standard hours are considered as Monday to Friday 6am to 5pm. Services delivered after 5pm will be charged the non-standard hours rate.

Minimum Visit

The minimum visit charge is for 15 minutes which will be charged a Short Visit rate.

Basic Daily Fee

The Basic Daily Fee paid by you will be determined according to care needs within the budget.

In addition, you may be assessed by the Government as needing to pay an Income Tested Fee.

Care Management

Every Home Care Package (HCP), including those being self-managed, will require some level of care management.

Care management is an important service that includes co-ordinating care and services that will help you achieve the the goals you identified in your Care Plan.





Resthaven provides two levels of care management:

Fully managed by Resthaven

When fully managed by Resthaven, the care management covers establishing and reviewing your Home Care Agreement and Care Plan, coordinating and scheduling service provision by trained, supervised staff, responding to lifestyle/cultural preferences, liaising with you, your support network and identifying/addressing safety risks.

Care management charges align to staff roles/skills and increase with complexity of care.

Approximate time per HCP level is indicated in the schedule. Requests and activity that exceeds the approximate hours indicated will incur additional care management charges at an hourly rate.

Self-managed Care Management

When self-managed, a fee is charged for activities Resthaven is required by legislation to undertake (establishment/review of the Home Care Agreement and Care Plan, supervision/scheduling of Resthaven staff). Approximate time is indicated in the schedule. Where you request Resthaven to provide additional activity, care management is charged, at an hourly rate.
