

#### **Short Term Restorative Care**

Resthaven's Short Term Restorative Care (STRC) Program provides services over an eight week period to improve your wellbeing and independence.

The services aim to improve your ability to complete everyday tasks, and delay or avoid the need for long-term care.

Resthaven's Short Term Restorative Care service is available to people living in metropolitan Adelaide, the Riverland, Murraylands, Fleurieu Peninsula and Limestone Coast of South Australia.

#### **Services**

Short Term Restorative Care is delivered by a team of health professionals, including your General Practitioner, to identify and treat any medical conditions.

Resthaven will work alongside you and your health team to support you to identify your goals and design your plan. Services can be provided in your home and/or at a Resthaven wellness centre.

# **Support may include:**

 Assessment/treatment by nursing and allied health professionals (individual therapy, home-based exercise, group exercise)

- Information about modifying home based tasks, equipment, nutrition, selfmanagement of health conditions, remaining independent
- Support to build confidence and reconnect with your community
- Other services to meet your goals.

## Eligibility and Referral

You may be eligible for Short Term Restorative Care services if you:

- are slowing down physically, or mentally, or both
- need help with everyday tasks
- want to stay independent, and out of long term care
- are not currently receiving a home care package or residential care.

To find out if you are eligible for Short Term Restorative Care services, you need to call My Aged Care on 1800 200 422.

Contact Resthaven if you would like us to assist you.

Short Term Restorative Care requires an assessment by an Aged Care Assessment Team (ACAT).

If you are eligible, ask the ACAT to provide a referral to Resthaven.

#### Fees

A subsidy is paid directly to Resthaven by the Australian Government. The subsidy contributes to the total cost of your services and care delivery.

It is expected that you will contribute to the cost of your care.

Resthaven will discuss with you and agree any fees before you receive services.
